Track 1: Inequitable Distribution: Reasons. Mistakes and Common Pitfalls 1.5 CLEs Pending

Track 1: Navigating Family Formation & Avoiding Conflict Under the New Child Parent Security Act 1.5 CLES Pending

The program will delve into the impact of New York's new parentage law governing children conceived using assisted reproductive technologies, the Child-Parent Security Act, on family formation and dissolution. We will explore how the intent-based construct of the CPSA facilitates third-party reproduction including egg, sperm, and embryo donation arrangements, and gestational surrogacy, and allows for one party's use of jointly created embryos following separation or divorce. Special consideration will be given to how divorce mediators and family law practitioners can best anticipate and assist clients in resolving the complex and often intertwined emotional and legal issues or conflicts that arise in this context.
