#### Making the Case for Caucusing in Divorce Mediation 1CLEs Pending

Some divorce mediators never use shuttle diplomacy, while commercial mediators use it almost exclusively. In this workshop, David Hoffman will present his views on why commercial mediators over-utilize caucusing and divorce mediators under-utilize it. Drawing on game theory, psychology, and anecdotal data, David will outline 12 situations in which caucusing is not just useful but essential.

#### What the Heck is a HECM? (Reverse Mortgages are Not What You Think!)

During this session, Bill Donofrio will review the myths, features and benefits of reverse mortgages, which are regulated by the FHA and government insured. Then he will explain how divorce mediators are using this financial tool to help divorcing couples aged 62 and older. Some use HECMs so that one party can buy the other out and stay in the marital home. Some use HECM loans to purchase new homes for both parties. This is your opportunity to learn everything you wanted to know about reverse mortgages, but were afraid to ask.

#### Retirement Account Primer for Mediators 1CLE Pending

This introduction or refresher workshop will cover some of the most valuable assets in the marital estate: the retirement accounts and pensions. Carolyn will review the basics of defined benefit plans, defined contribution plans, vesting, and other terminology that may often seem dense and confusing to the uninitiated. She also will review different methods of division, dealing with pre-marital contributions and post marital contributions to accounts, and the differences between private sector (ERISA governed) and governmental plans. Issues of discovery of financial information and QDRO drafting also will be addressed.

### Addressing Diversity, Inclusiveness and Implicit Bias: Concerns Facing Mediators

**2 CLEs** Pending

How best to embrace diversity and inclusiveness have been the focus of extensive attention for the mediation field. The larger discourse raises concerns about the people involved, the process itself, and the profession. Like all mediators, divorce mediators are expected to create an equitable environment to help the parties reach agreements despite the fact that everyone in the room comes with their own biases, perceptions, cultural experiences, values, and assumptions, many, if not most, which are interwoven to result in implicit biases. These unconscious attitudes, whether favorable or unfavorable, influence mediation sessions and outcomes. This session will discuss strategies of looking inward at self and outward at others, how to be mindful of the mediation standards of conduct to manage biases, and how to incorporate principles of diversity and inclusion into divorce mediation practice.
